RNCF Levy Scheme

In order to raise funds for our valuable work RNCF relies on financial support from schools. One method we have developed – which represents nil cost to schools – is the RNCF Levy.

A school, on behalf of RNCF, adds an optional surcharge (usually between £5 and £10) to the termly fee. The funds generated through the RNCF Levy allow us to support more vulnerable children each year (currently 330 children) at independent boarding / day schools and state boarding schools in the UK.

How It Works

- After an initial meeting an agreement is set up between the school and RNCF
- An explanatory letter and information pack is sent to parents
- An optional RNCF Levy sum is added to the termly bills
- The funds are collected by the school and paid to RNCF termly.

Benefits

- Your parents and schools can demonstrate charitable support of children who are most vulnerable in society
- RNCF helps a greater number of deserving children by working with other Trusts and subsidising more bursary places
- A RNCF levy contribution can be used to evidence the Charity Commission requirement for Public Benefit.
